Government College for Women Bahadurgarh is an educational institute headed by Principal under Higher Education Department of Haryana Government. The institute is affiliated to Maharshi Dayanand University, Rohtak and follows the guidelines of DHE Haryana and MDU Rohtak. The institute offers four under graduate courses B. A, B. Com, B.Sc (Medical) and B.Sc (Non- Medical) only for females. The main duty of the institute is to provide education to students. Every teacher is responsible for his / her subject and is assessed by results through Principal/ DDO. The administration of the college is done by assigning duties to teachers through forming cells/ committees like IQAC, College Council, NAAC, Sports, Women Cell, NSS, Cultural Committee and Placement Cell. The norms for the discharge of its functions are issued by DHE/ employer time to time and are implemented accordingly. The norms relating to curriculum, examination and assessment are provided by the affiliating university. The college comes under "Government. – Grant" category & student 's funds are collected as per the Haryana Education Code. Therefore, financial transactions are audited by the auditors of Accountant General, Haryana (Govt. Grants) as well as local audit Haryana (for funds collected). The college has different bodies to maintain discipline in the campus. All the cells and committees of the institution are under the college Principal.

Policies are formulated by DHE, Haryana and if there are any grievances the information can be obtained through PIO. The information relating to public domain is accessible through proper channel. The applications under the RTI ACT 2005 along with a postal order/ demand draft of Rs. 10 are obtained in favor of Principal Government College for Women Bahadurgarh. The applications are sent to the state public information officer (SPIO) or handed over in his/ her office.
